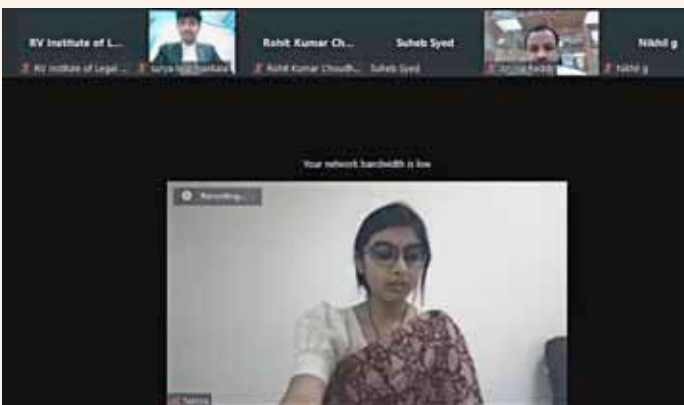
18th and 19th December, 2021: Virtual International Conference on International Arbitration Contemporary Issues and Challenges

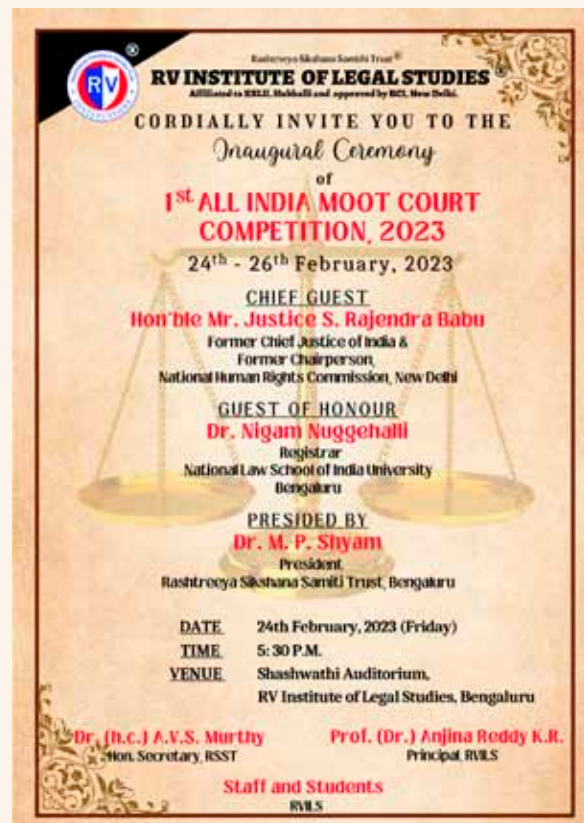
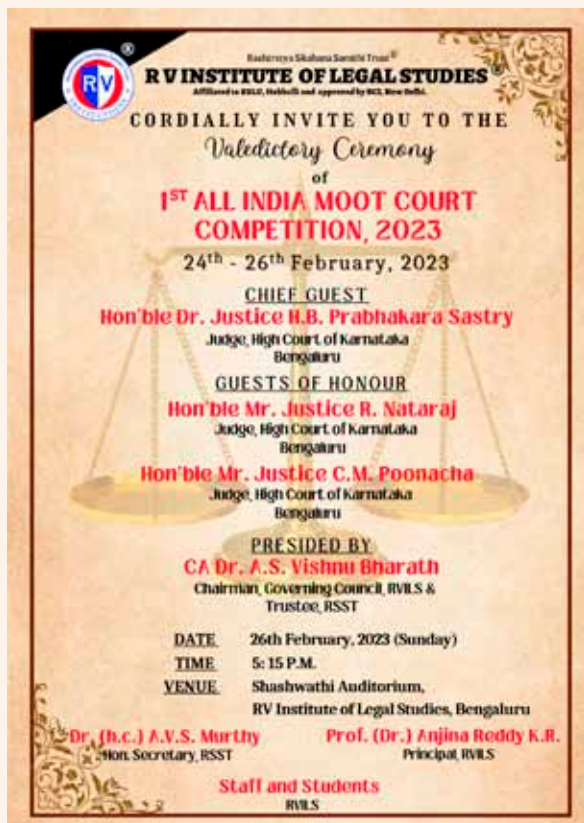
Our college had celebrated the 74th Republic Day by hoisting the National flag. Principal, Staff and students were part of the Republic day celebration.

Alternative Dispute Resolution in the Criminal justice system is Uncommon

Introduction :

Alternative Dispute Resolution is the best suggestion in current civilisation as a simple method to get justice. Because of the huge pendency of suits, the intricacy of legal justice and time-consuming formal procedures, legality is hardly a promise. There is a saying 'Justice hurried, justice buried'. The scenario in India, Bangladesh, Pakistan etc. are developing and underdeveloped countries where ADR is not upto the mark compared to other countries. Eventually, ADR has been used by traditional communities for a lengthy time period. Because access to the judiciary is more costly, difficult and takes a lot of time, people started using the Alternative Dispute Resolution over validated judiciary. Communities are always bothered about resolving the disputes and issues to reduce the complications.¹

There is a wide range of understanding by the people that law acts as a caretaker and looks after the disputes of the people in the society. Besides, the judiciary is always substantive and procedural. People come and approach the court in different matters such as litigation, property, crime, family matters etc. Among the above mentioned matters, leaving behind crimes, others are dispute matters. Nowadays a query has been popped up by the communities as well as the legal representatives, is punishment the only solution for a crime?

How there can be no other options for solving a dispute?

Apart from legal action, Alternative Dispute Resolution (ADR) is a unique technique of settling issues and disputes. A third party must settle the dispute without any bias by utilising processes such as arbitration, negotiation, mediation, and conciliation. The court will not be involved in resolving the dispute when the above mentioned processes are in action.

Irrespective of civil law, criminal law necessitates much care in the process of interpretation, as well in execution just a small mistake that will lead to a great loss of law and order. Alternative Dispute Resolution gives few distinctive ways of solving many types of offences even though there are other possibilities.²

Alternative Dispute Resolution in India :

Judiciary being one of the oldest legal systems in the world, courts in India having many unsolved cases making the legal system in India increasingly ineffective in handling litigations which are pending. Over hundreds of fast track courts are established to minimise the huge pendency of cases because of the rise of unresolved litigations in the country. The ways of resolution of the dispute are as follows such as arbitration, mediation, negotiation, conciliation and Lok Adalat, all of these are offered by Alternative Dispute Resolution. However, the Indian judiciary did not recognise counselling between the parties itself which is referred to as negotiation. Articles 14 and 21 of the fundamental rights of the Constitution of India, deals with equality before the law which is Art-14 and the right to life and personal liberty which is Art-21, these two are additionally the foundations of Alternative Dispute Resolution in India. Political, economical and social justice will be achieved by ADR as it is the main purpose and mentioned in its preamble which also protects or defends the integrity of society. Article 39-A which is to ensure access to equal justice and free legal representation of the Directive Principles of State Policy (DPSP) of Part - IV of the Indian constitution has also been ensured by Alternative Dispute Resolution as an additional goal to it.

The process of Alternative Dispute Resolution is extracting fame in recent times. Alternative dispute resolution will not restore the litigations and resolves the dispute matter between the parties using many other ways mentioned in the Alternative Dispute Resolution. Alternative Dispute Resolution in the simplest way means solving the disputes without the intervention of the court. Alternative Dispute Resolution can also be practised in various forms in many countries. In a country like India, the usage of arbitration and mediation is most often. Diversity of proficiency is circumscribed by Alternative Dispute Resolution.

Hence, ADR necessitates the best process or outline which suits the respective dispute and also the parties in dispute, not only the various methods to resolve disputes.³

Few modes of ADR are as follows :

Arbitration : Dispute resolution which takes place at the international level mainly takes the form of arbitration over disputes between parties in certain circumstances of the case. The arbitrator decides on the case and the decision is either binding or non-binding on the parties according to the situation. As a form of dispute settlement, arbitration is a process in which an independent third party examines a dispute and listens to both parties in order to reach a decision binding on both parties. Arbitrators can enforce their decision when necessary.

Mediation : In contrast to arbitration, mediation is a much easier process to handle. There will be a third party involved in mediating between the two parties in a mediation. In the case of individual matters mediation is preferred at maximum in India. Issues will be resolved between the parties by the way of mediation, the parties will arrive at a decision through the assistance of a third party. The decision which is made through a mediator is not dischargeable like an arbitral award.

Conciliation : A neutral person helps the person to arrive at a negotiated settlement through the method of conciliation of resolving the disputes. A decision can not be enforced by a conciliator because he/she does not have power to do so.

Negotiation : Negotium is a latin word and the word negotiation is derived from it. This process will not consist of a formal approach between the parties itself or their legal representatives. This is the fastest and cost friendly form of solving the dispute. There is no third entity overseeing the affected persons' decisions, no process begins until all participants meet, and no parameters or regulations exist for the process. Negotiating is the process the parties use to reach agreements with each other, whether it's an agreement reached between the parties themselves or their legal representatives like bargainers.

Criminal trials in India :

Alternative Dispute Resolution procedures have become much more widely used in the Indian judicial system as a result of the advantages they offer. It enables a swift trial, is a private process, and is a cost-effective way to resolve conflicts. As a result, it circumvents the vast majority of difficulties brought up by litigation as a settlement process.

Conclusion :

The Indian Criminal Jurisprudence has moved on from not recognizing the idea of alternate dispute resolution in criminal cases to incorporating the idea of plea bargaining into the Criminal Procedure Code (CrPC) and establishing guidelines to recognize mutually agreed-upon dispute resolution in cases that are not of a serious nature and do not have an impact on society as a whole. As an exception to traditional court procedures, alternative dispute resolution (ADR) ought to be utilised more extensively and frequently to alleviate court workload. Accordingly, such external court settlements are vital to diminish the over the top weight on the courts and ought to likewise become ordinary.

In conclusion, it is extremely challenging for the average citizen to obtain administrative justice under an organised criminal regime. Therefore, it is always preferable to settle the dispute jointly outside of administration if there is a chance to obtain minimal justice. In fact, in this legal field, alternative conflict resolution mechanisms are highly valued not only for reducing court case backlogs but also to guarantee access to justice. Alternate Dispute Resolution also offers a viable and inviting alternative to not taking action against injustice for those seeking justice. When a criminal deserves harsh punishment, a plea bargain may appear to be nothing more than monetary compensation for the offence and a compromise of justice. However, from the victim's (or defendant's) perspective, criticising the wrongdoer is far more effective because a court imposes a fine.⁴

Parallel ADR institutions must substantially expand across the nation. They need to be set up at remote levels in the same way that courts of law were set up.

There must be centres for arbitration and mediation in every court. This would guarantee that the ADR forum would first handle any disputes that could be resolved through ADR. The matter should only be taken to the courts if the parties are unable to reach a settlement.

The majority of the commercial disputes handled by the Arbitration and Mediation Centres and Institutions in India currently exist. Either new private bodies for non-commercial disputes (such as family disputes) must be established.

Without the public's awareness and enthusiasm for ADR over the courts, the country's establishment, empowerment, and legal recognition of ADR bodies would be useless.

By regularly performing street plays, weaker and less fortunate groups can be taught about ADR options. Such execution must be made in the nearby tongue and language of individual regions.

Measures must be taken to encourage the use of ADRs on a more voluntary basis until ADR becomes a mechanism that functions in parallel to the legal system.

The Indian Constitution's promise of justice to the people is at risk. In point of fact, mechanisms represent the hope of realizing the Constitution's promises. ADR is a promising option for ensuring nationwide access to justice due to its simplicity, lack of technicality, privatisation and speed. Instead of proceeding to a formal court decision, civil litigants should be encouraged to investigate whether their dispute can be resolved by agreement, either directly or with the assistance of a third party mediator or conciliator.

ADR must be incorporated into the civil justice system because it is a crucial means of expanding citizens' access to individualized justice in appropriate circumstances. The legal system must enthusiastically embrace changes.

In a cyber-crime, the computer or the data is the target, the thing of the offence, or a tool used to commit another offence by furnishing the necessary inputs. Judicial Intervention In Women Empowerment

Introduction :

The principle of gender equality is enshrined in the preamble, basic rights, obligations and policy principles of the Indian Constitution. The Constitution not only guarantees equality for women, but also empowers the state to take positive discriminatory measures in favour of women. Our laws democratically formulate policies, plans and programs aimed at the advancement of women in various fields. Since the Fifth Five-Year Plan (1974-78), the approach to women's issues has largely shifted from welfare to development. In recent years, women's empowerment has been recognized as a central issue in determining women's status. The National Women's Commission was established by an Act of Parliament in 1990 to protect the rights and legal rights of women. The 73rd and 74th Amendments to the Constitution of India (1993) provide for the reservation of seats in the local committees of panchayats and women's parishes.

- The policy also takes note of the women's empowerment policy work in the 9th Five Year Plan and other areas.
- The women's movement and extensive NGO network with a strong grassroots presence and deep understanding of women's issues have contributed to inspiring efforts to empower women.
- Gender inequality takes many forms. The most obvious trend is that the proportion of women in the population has been steadily declining in recent decades. Other symptoms include social stereotypes, domestic violence, and societal violence. Discrimination against girls, adolescent girls, and women continued in parts of the country.
- The underlying causes of gender inequality are related to social and economic structures based on informal and formal norms and practices.
- Consequently, women, especially those belonging to registered castes/tribes and other vulnerable groups, including those of the underclass and minorities, who mostly live in rural areas and informal and unorganised sectors, Access to education, health, and productive access is undermined. Decrease or lack of resources. As a result, they remain marginalised, poor and socially excluded.

1. Policy Prescriptions Judicial Legal Systems

- The development of property rights in the patriarchal system contributed to the subordinate status of women. The policy aims to encourage changes in laws related to property and inheritance rights by forging a consensus to make them gender equal.

Decision Making

Ensure women's equal rights in sharing power and actively participating in decision-making, including decision-making at all levels of the political process, in order to achieve the goals of self-determination. Every step is taken to ensure women's equal access to and full participation in decision-making bodies at all levels, including legislative, executive, judicial, corporate, statutory bodies, advisory boards, commissions, boards, foundations, etc. I'm here.

2. Economic Empowerment of women:

Women make up the bulk of the population below the poverty line and, given the stark reality of discrimination within the family and within society, very often live in conditions of extreme poverty, so macroeconomic policies and Poverty reduction programs will specifically address the needs and problems of women. Elimination of discrimination, generalisation of education, eradication of illiteracy, development of a gender-sensitive education system, improvement of enrollment and retention of girls, improvement of quality of education for lifelong learning and career promotion, vocational and Special measures are taken to improve technical skills. Woman. A priority would be to reduce the gender gap in secondary and tertiary education. Gender-specific curricula will be developed at all levels of the education system to address gender stereotypes as one of the sources of gender discrimination.

Environment :

Women are also involved and women's perspectives are taken into account in environmental, conservation and restoration policies and programs. Consider the impact of environmental factors on livelihoods and ensure women's participation in preserving the environment and curbing environmental degradation.¹⁰

Violence against women :

All forms of physical and psychological violence against women, whether domestic or social, including those arising from customs, traditions or accepted practices, must be effectively combated to eradicate their occurrence. It won't work.

Rights of the Girl Child :

All forms of discrimination and violations against girls must be eliminated through strict preventive and punitive measures both within and outside the family. These particularly relate to strict enforcement of laws prohibiting practices such as prenatal sex selection, child murder, child marriage, child abuse and child prostitution.

International Treaties and Conventions:

UNFPA (United Nations Population Fund) is a subsidiary body of the United Nations General Assembly. With a focus on reproductive health and gender equality, it plays a unique role within the United Nations system in addressing population and development issues. Work in the areas of gender equality and

The General Assembly adopted the convention in December 1979, and by 2004 it had been ratified by 179 countries.

Legislative Initiatives towards Empowerment of Women in India :

India has a number of laws aimed at empowering women in the areas of personal, labour, services, punishment and socio-economic issues. The basic law of this country, the Constitution of India, guarantees the equality of women. It would be appropriate to mention some of the most important laws for empowering women.

1. Constitution of India, 1950:

The Constitution of India not only guarantees equality for women, but also empowers the state to take measures to prevent discrimination in favour of women. The principle of gender equality is enshrined in the Preamble, Fundamental Rights, Fundamental Obligations and Policy Principles of the Indian Constitution. Article 14 of the Indian Constitution guarantees equality before the law. Article 15 prohibits sex discrimination. Article 16 establishes equal opportunities for all citizens with respect to employment. Amendments to Articles 73 and 74 of the Indian Constitution provided for the reservation of seats (at least one-third) in the local committees of panchayat and women's parishes. Another constitutional amendment (the 108th Amendment to the Constitution) that would provide for 33 percent in Congress and state law is in preparation.

2. Indian Penal Code, 1860:

Articles 292, 293 and 294 provide for opposition to the sale and display of obscene books and penalties for obscene conduct in public places. Section 304(b) deals with the killing of women in connection with dowry demands. Articles 312 to 318 deal with penalties for causing miscarriage. Article 354 provides for penalties for acts that disregard a woman's modesty, and Article 366 deals with abduction for the purpose of marriage against a woman's will. Section 366-A deals with procuring underage girls for sexual purposes. Section 376 deals with the punishment of rape. Article 494 protects women from bigamy. Article 497 deals with protecting married women from extramarital affairs. Section 498-A of the Indian Penal Code deals with cruelty to a woman by her husband or her relatives and his husband, and Section 509 deals with words, gestures or actions intended to humiliate a woman. stipulates punishment.

3. Code of Criminal Procedure, 1973:

Under S. 125, Code of Criminal Procedure, a woman has got the right to maintenance.

4. Indian Evidence Act, 1872:

Sections 113(a), 113(b) and 114(c) provide for presumptions as to abetment of suicide by a married woman within 7 years of marriage, as dowry death of a woman and as to absence of consent of woman for sexual intercourse.

5. The Dowry Prohibition Act, 1961:

According to the provisions of this law, asking for a dowry before, during and/or after marriage is a crime. 10. Islamic Women (Protection of Rights in Divorce) Act 1986: The Act provides for the upbringing of women by relatives even after the iddat period. 11. Factories Act 1948: The provisions of this Act regulate the health, safety, welfare and working hours of women workers in factories.

6. The Equal Remuneration Act, 1976:

It provides for equal pay to male and female workers for the same work or work of a similar nature. Discrimination against women in recruitment activities is also prohibited.

7. The Maternity Benefit Act, 1961:

It provides maternity benefits with full wages for women workers.

The law provides for the establishment of the National Women's Commission, a statutory body to take corrective action, facilitate grievance resolution, and advise the government on all policy issues related to women.¹¹

The judiciary reached out to the women, but Congress refused. The judiciary's recent landmark ruling shows that judges cannot be blamed for gender inequality.¹²

Equal Rights of Women over property

Introduction :

Women are fighting for hundreds of years to get family property rights. Across cultures, the notion that girls don't permanently remain in their birth families has led people to disapprove giving them property rights. After they marry, they enter their marital family and become an element of it, so only male members have rights to family property. However, women's property rights have changed significantly in recent decades.

They play during various stages of their life, as a daughter, wife, mother, and sister etc. Despite her contribution within the lifetime of every individual. Still she belongs to a category or group of society which is during a Disadvantaged position on account of several social barriers and Impediments. She has been the victim of tyranny at the hands of men who Dominates the society.

The position of Indian woman isn't any better compared to their counterparts in other parts of the globe. The earliest legislation which brought females into the scheme of inheritance was 'The Hindu Law of Inheritance Act, 1929', which conferred inheritance rights on three female heirs, that is son's daughter, daughter's daughter, and sister. During this era another landmark legislation conferring ownership right a girl was 'The Hindu Women's Right to Property Act, 1937'.

This Act of 1937 enabled the widow to succeed together with the son and to require the identical share because the son, the widow wasn't a coparcener, while she possessed a right like coparcener's interest within the property and was a member of the joint family.

However, before the commencement of 'The Hindu Succession Act, 1956', the property held by a Hindu female was classified under two heads:

1) Stridhana and 2) Hindu Women's estate.

Females Who Are Entitled To Get A Share?

1) Wife:

Whenever a partition takes place between her husband, then the father's wife is entitled to induce a share capable the share of son. She will be able to hold this share and revel in it separately from her husband.

2) Grandmother:

When partition takes place between her grandsons (son's son) her son being dead, she is entitled to a share up to the share of a grandson.

3) Mother:

Whenever a partition takes place among the sons, a widowed mother encompasses a right to require a share equal to the share of son. This right accrues to her only partition by metes and bounds takes place.

4) Daughter:

The daughters now have equal right of inheritance to their father's estate as sons. The daughters have a right to receive a share in mother's property. The Hindu Succession (Amendment) Act, 2005 removes discriminatory gender that was within the provisions of the Hindu Succession Act, 1956 and now it gives the varied rights.

5) Widow:

Now, it seems to be settled law that after Partition their husband then each widow acquires a right of survivorship together with this either widow also gets the correct to partition with or without the consent of the opposite or others. Thus, coparcener widow can put an end to joint status of the fam.

The Hindu Act To Property Right 1937

To confer better, equal, and significant inheritance rights to the ladies, the Hindu Women's Right to Property Act was passed in 1937 basically to amend the Hindu law of succession amongst all the faculties. It made innovative changes within the Mitakshara law. In fact, it affected the law of coparcenary, partition, alienation, and succession.

It conferred upon the Widow of a person, whether governed by the Mitakshara or the Dayabhaga Law, right to inheritance to the property even when he dies forgoing a Male issue. Similar rights were conferred upon the widows of his pre - deceased son and therefore the widow of pre-deceased son of a pre-deceased son.

After this Act, within the Mitakshara undivided family the widow of a deceased coparcener was entitled to require his interest within the joint family. all told cases, widows were entitled to assert partition. All the females took a limited estate. Prior to the passing of this Act the widow in respect of the separate property left by her deceased husband had no right of inheritance.

If the deceased husband had left a son, grandson, or great grandson then the widow had only right of maintenance. She could inherit as an heir to her husband in respect of his separate property only when he had not left any son, grandson, or great grandson. Even when within the absence of these persons she inherited as an heir, she would be divested of the identical, the instant she adopted a son to her husband.

By the Act of 1937 new rights of inheritance are conferred on her and he or she had been given the correct to inherit her deceased husband's property within the same manner because the son. In other words, the Act has made her co-heir with the sons and entitled her to inherit in her husband's property the same share as that of a son. Within the case of over one widow.

The Act together gave them a share capable that of a son. Similar rights were conferred on the widow of a predeceased son and the widow of a predeceased son of a predeceased son. Thus, the Act had its applicability when a Hindu dies intestate either partially or wholly.

Hindu Succession Amendment Act, 2005

The Hindu Succession (Amendment) Act, 2005 (39 of 2005) was enacted to get rid of gender discriminatory provisions within the Hindu Succession Act, 1956. Under the amendment, the daughter of a coparcener shall by birth become a coparcener in her claim within the same manner because the son. The daughter shall now have the identical rights within the coparcenary property (ancestral property of the Hindu undivided family) as a son.

Prakash vs Phulavati (2016)2 SCC 36

In this case, the respondent (Phulavati) had initially filed a partition suit before the court in 1992, after her father's death. She claimed 1/7th share within the properties that her father acquired from his mother. While the suit was still pending, the Hindu Succession (Amendment) Act, 2005 was made effective. The Amendment gave coparcenary rights to the daughters also. Phulavati used the opportunity; she amended her previous claim as per the 2005 Amendment. The court only partly allowed her suit.

Following the Trial Court's order, Phulavati approached the supreme court stating that she, being a coparcener as per the 2005 Amendment, has share adequate to her brothers in the father's property. The appellant (Prakash, Phulavati's brother) contended that the 2005 Amendment won't apply in the present case, because the father died prior to 2005. The supreme court ordered in Phulavati's favour and allowed the retrospective effect of the 2005 Amendment.

Aggrieved by the High Court's decision, Prakash approached the Supreme Court. Finally, the Supreme Court overruled the High Court's decision and held that the 2005 Amendment won't apply to any partition which was affected before its enactment.

Danamma vs Amar Singh (2018)

In this case, the appellants were the two daughters of Late Shri Gurulingappa Savadi and his widow, Sumitra. The couple also had two sons, Arun Kumar and Vijay. Amar Singh, the son of Arun Kumar, filed the partition suit claiming a one-fifteenth share in Savadi's property. His claim was based on the fact that the property was in the possession of the two sons and the widow.

He contended that the two daughters were not the coparceners, as they were born prior to the enactment of the Hindu Succession Act, 1956 as amended in 2005 (the Act). The Hon'ble Supreme Court after giving due appreciation to the facts and also the matters of law involved within the case opined that Mitakshara law has undergone tremendous amount of change and also the said changes are brought forward to deal with the growing must merit equal treatment to the closest female relatives.

Namely daughters of a coparcener, the bench further opines that the section 6[1] of the Hindu Succession (Amendment) Act 2005 no doubt secures the choice of the difficulty within the favour of the Appellants as because of the 2005 amendment, the act now endows the status of coparcener both on the daughter of the coparcener and also the same on the daughter of the propositus further.

This status is of the identical manner because the son of the propositus and provides the identical rights and liabilities within the coparcener properties as she would have had if it had been son.

Veenita Sharma vs Rakesh Sharma (2020)

In this case, the appellant's father died in 1999. She had three brothers and a widowed mother. One of her brothers died unmarried in 2001, after which she filed a suit claiming coparcener ship and one-fourth share in her father's property. But the High Court rejected her claim stating the fact that her father died before the 2005 Amendment.

The High Court's decision brought confusion to the retrospective effect of the 2005 Amendment because of the two previous contradicting decisions in the cases Danamma V. Amar Singh (2018) and Prakash V. Phulavati (2016).

Clarifying this chaos, a three-judge bench of the Supreme Court led by Justice Arun Mishra gave a landmark verdict on the 11th of August 2020. The bench upheld its decision in the case of Danamma V. Amar Singh and overruled Prakash V. Phulavati. It held that a daughter is considered a coparcener by birth, irrespective of whether her father is alive or not. Further, the retrospective effect of the 2005 Amendment was also upheld and well-settled in this case.

Conclusion

The world is changing. Gone are the times when patriarchy ruled women's rights and needs. Women have become more independent than ever before. Due to education and technology, today women needn't depend on the age-old tradition of Stridhana to satisfy their post-marital needs. And that's why Stridhana is slowly disappearing from the face of contemporary Indian societies. The eradication of the archaic tradition is empowering women to be entitled to property rights just like that of their male counterparts.

Neutral Citation System

Introduction:

'Neutral Citation System' is an initiative of Chief Justice of India, D.Y. Chandrachud, aimed at evolving a mechanism for standardizing case law citations. The Supreme Court adopted a "Neutral Citation System" for its judgments. As a matter of principle, a Neutral Citation would mean that the Supreme Court will issue its own citations in different ways from those issued by regular legal reporters. There will be a citation format that has been approved by the court; it will be particular to each decision and unrelated to any particular body of law reports or other publications. The Supreme Court would have a unique citation that would make it simple to locate, reference, and retrieve it. [1] The High Courts of Delhi, Madras, and Kerala have already introduced this system. Neutral citations are going to be issued for all 30,000 judgments.

The CJI established a sub-committee to develop a uniform national format for impartial quotations of Supreme Court and high court decisions. A unified national model for producing and awarding neutral citations should be implemented, the subcommittee ruled after soliciting views and considering various aspects of a neutral citation system.

What is a Legal Citation?

In legal terminology, a reference to the specific law source such as constitutions, laws, reports, cases, treatises or articles on judicial review may be cited. The first volume number, the title of the source, usually abbreviated, and the last page or section number shall be included in the standard citation. A legal citation shall mean that it deals with a particular legal source, like the constitution, legislation, case reports, regulations, texts, and reviews of law. The volume number, short title of the source and starting page or section numbers are also included in the basic format. When legal experts argue before the courts and when judges are writing their opinions, they draw on authority. They reference statutes, regulations, court rulings and past appeals decisions they believe to be important and supportive of their representation of the law as it relates to a situation. Case citation helps the professionals and the public to understand the decisions of the case.

What is a Neutral citation system?

A neutral citation system means that, unlike traditional law reporters, the court would lay down its own distinct citations. The law reporters are nothing but periodicals or annual digests which publish judgments, often with an editorial note, so that legal practitioners can access them to refer to precedents. There are many reporters who are admitted to India's extensive federated legal system, each with its own citation style. India has around 200 law reports, both authorized and unauthorized. In India, the Delhi High Court was the first to implement a neutral citation system. The neutral citation is medium neutral, meaning that regardless of the medium in which the decision has been published, its uniqueness remains unaffected.[2]

The traditional citation method for case laws in India largely depends upon the format used by the reporters who publish that piece of judicial pronouncement delivered by the Courts, Tribunals, or any other Judicial or Quasi-judicial bodies. Till now the SC was dependent on third-party organizations and journals, for example, SCC (Supreme Court Cases), AIR (All India Reporters), Manupatra, etc. It did not have its own independent citation system. But now it will, it will now have a neutral citation system for all its judgments. This will be applied retrospectively. The older previous citations will be given a new citation. This will reduce the complexities of having more than one citation for a single judgment. This mode of citation is exclusive and permanent in nature and character.[3]

A neutral citation contains the following parts:

- The Parties' names.
- The year when the judgment was published.
- A distinctive abbreviation used to identify courts.
- A number assigned to each judgment in order by the specific court.
- A specific paragraph reference.

It should be emphasized that each paragraph should have a unique number starting with the first one in the published judgment.

Hence, a neutral citation would be written as:

(Name of the parties involved) [the year of the judgment] (The court's acronym) (the judgment's sequential number) [paragraph number].

Why is there a need for a Neutral Citation System in India?

The basis of a case law citation is a paper-based reference to judicial decisions. This method of operation, while imperfect, did not present any significant issues up until recently. However, as it generates new needs, the recent emergence of digital media has exposed the shortcomings of the conventional method. Calling for changes to the current citation standards to satisfy the new needs of the Courts has nearly become a necessity with the introduction of electronic media into the operation of the judiciary. This can only be made easier by hastening the release of court rulings into the public realm. The creation of electronic research tools that can meet all expanding demands of the judicial machinery with the growing relevance of electronic media would be considerably facilitated by the availability of a singular, trustworthy, authoritative, accessible, expeditious, and permanent citation for cases. It is now crucial to establish a citation style that would take into account the fact that electronic media is becoming heavier by the day.

Conclusion:

A neutral legal citation will encourage a new generation of tools and capabilities, which will be advantageous to all parties and enable commercial organizations to produce a new generation of goods and services, limited only by their creativity and capacity for innovation. There are still many courts and bar associations, particularly in rural India, that need to be convinced of the benefits that the system of neutral citation carries as a whole. This is because the penetration of electronic media and legal familiarity with emerging technologies varies dramatically between Indian jurisdictions. The approach will significantly aid in reducing the current monopoly of a select few publishers over citation styles, ensuring the viability of smaller companies in this enormous publishing market.

The money that is collected as taxes, fines by the government is mainly to be used for development of infrastructure of the country but due to the desire to mint money as Much as possible the government officials, political leaders, would loot the money that had to be distributed to various activities for example if the money allocated for building roads is 10 Lakh for a locality but the counsellor of the area spends only 5 lakhs and takes the left over 5 lakh for is personal use this may not affect us directly but the money he spent may not be Enough as the quality and proper completion of work would not be present.

Hence placing unqualified, incompetent people in authority would result in misuse of power and would lead to corruption. The money that is borrowed from world banks, for developmental purposes would be transferred in benami accounts in foreign countries or islands such as Mauritius and panama islands it's

estimated that more than 12 lakh crores of black money has been invested in Swiss banks and hawala transaction as per reports in 2017 before demonetization. Some of the famous scams and scandals involves.

- The Telgi scam also called as the stamp paper scam which involved issuing fake stamp papers which resulted a loss for the government of 9.92 crores in 2001 and a sum of 20000 crores was recovered from Abdul Karim Telgi in 2003 in Bengaluru.
- The Jain diaries case also called as the hawala scandal involved transferring of black money through hawala agents / brokers. PIL was filed in the apex court regarding this matter, it involved politicians like L.K. Advani, V.C. Shukla, Devi Lal, Sharad Yadav, Balram Jakhar and Madan Lal Khurana and many more. Conversion of foreign currencies to Indian rupees through investments and donations was the loophole of the case and it involved transactions from Dubai based banks as well.
- The Bofors scandal - It all began in 1986 when India signed a \$285 million deal with Swedish arms manufacturer AB Bofors for the supply of Howitzer guns for the Indian Army. The deal however snowballed into a major bribery scandal as local Swedish reports claimed Bofors had bribed Indian politicians to secure the deal.
- 2g spectrum scam - It is a combination of three cases, one filed by Enforcement Directorate and two cases registered by the CBI. A report by the CAG of India revealed that 2G, or second generation licenses for mobile networks, were given at throwaway prices instead of carrying free and fair auctions. The then Telecom minister, A. Raja, denied all charges and said that the decisions were made after then-apprising PM Manmohan Singh. A Raja was arrested in 2011 on charges of cheating, forgery and conspiracy. CAG submits a report on 2G spectrum to the government, stating a loss of Rs.176,000 crore (US\$22 billion) to the exchequer.

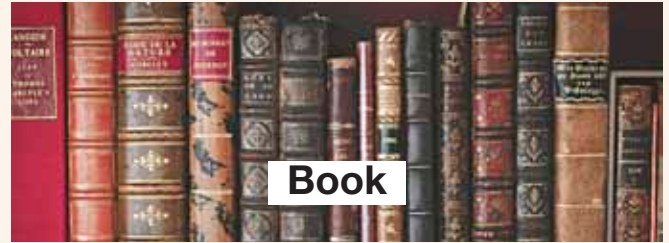

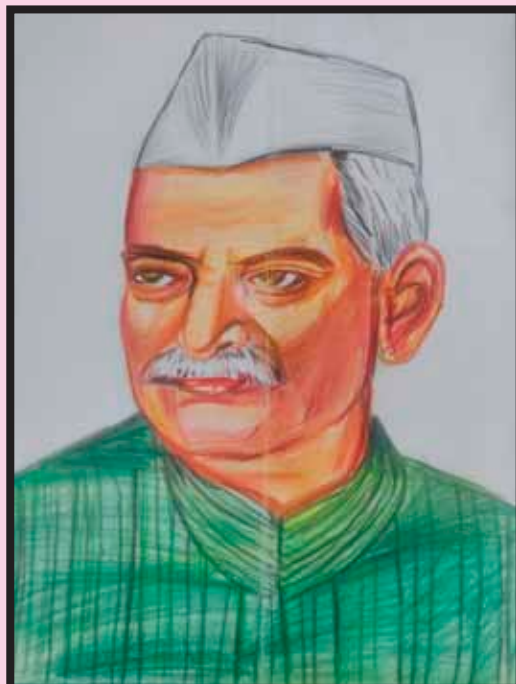

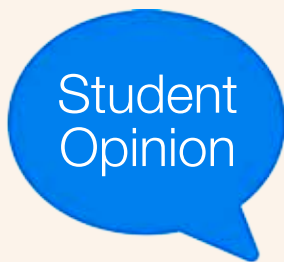
