#### **LIBRARY**

#### **CLASSROOMS**

Classrooms are spacious, well- ventilated and designed with all the modern teaching aids needed to support technology enhanced learning. They are equipped with projectors and screens, conventional LAN connectivity and are also Wi-Fi enabled to ensure excellent learning environment.



#### **MOOT COURT**

Moot Court provides students with innumerable opportunities to hone their skills in law, such as team work, research and oratory skills, where students argue on fictional facts in simulated setting. Institution has a well-furnished and spacious Moot Court Hall. All the students are given training to participate in the Inter and Intra College Level, National and International Level Moot Court Competitions. Students are also taken to the District Courts & High Court to observe the regular proceedings which ensure their participatory learning.



#### **COMPUTER LAB**

To provide improved access to educational opportunities and accelerate learning, we have a separate computer lab with broadband internet facility. This also ensures enhanced computer skills amongst our students.







#### **LEGAL AID CELL**

To promote equal access to courts and justice, the cell seeks to promote free legal aid to the socially marginalized sections of the society. The cell enables interactive pedagogy wherein the teachers and students engage in a variety of community outreach program through Legal Aid. This provides students an opportunity to serve people who are in dire need of their knowledge and skills.

#### PLACEMENT AND INTERNSHIP CELL

The institute has set-up a placement cell with training facilities for effective placements of students on completion of the course. Students are trained in required soft skills and professional skills.

The cell also coordinates internship opportunities for the students.

#### **AUDITORIUM**

There are 2 auditoriums with seating capacity of about 300 and 1,200. They are used for conducting seminars, conferences, cultural programmes, students' events and other important events of the institute.

#### HOSTEL

Separate hostel facility is provided for boys and girls. The rooms are spacious, furnished and well-ventilated. Homely and hygienic food is provided. Adequate measures are taken to ensure the safety and security of the students.



#### **SAFETY**

Safety in the campus is assured with 24/7 presence and patrolling by the security personnel. Institute is also under CCTV monitoring and is equipped with fire extinguishers and emergency exits to meet the needs of contingencies, if any.

#### **OTHER FACILITIES**

Keeping in mind the all-round development of students, the institute makes sure that adequate facilities for recreation are provided. Various facilities for sports - both indoor and outdoor are available for use by the students, institute also has ample space for outdoor sports like badminton, volley ball, football and cricket etc. There is campus cafeteria and canteen, separate girls' and boys' leisure rooms, book store and photocopy facility.

# Regulatory Norms for Admission B.A.,LL.B. & B.B.A.,LL.B.

(5 Year Integrated Degree Course)

### **Objectives**

To offer students the opportunity to study law from an extensive catalogue of optional subjects, covering the entire range of legal knowledge; to develop student's analytical and research skills, equip them with the generic skills they will need in their future careers. Also, to educate and prepare a diverse group of men and women with the knowledge, analytical ability, and management perspectives and skills needed to provide leadership to organizations competing in a world increasingly characterized by diversity in the workforce, rapid technological through B.B.A.,LL.B. and describe, analyse, and interpret students' own creation. Produce creative works that demonstrate innovation in concept, formal language and/or materials. Compare and contrast contemporary work with their historical antecedent through B.A.,LL.B.

#### **Eligibility Criteria**

An applicant who has successfully completed regular Pre-University Course or Senior Secondary School Course ('10 + 2' Pattern) from an Institution recognized by the Central or State Government in India or any equivalent Institution from a Foreign University, recognized by the Government of that country and also recognized in India may apply for Five Year Integrated Degree Course in Law leading to the conferment of Degree in B.A.,LL.B. / B.B.A.,LL.B. upon successful completion of the regular programme conducted under the regulations governing the respective course as formulated by the Karnataka State Law University, Hubballi.

### **Percentage of Marks**

- Minimum of 45% marks in the qualifying examination (General Merit)
- Minimum of 42% marks in the qualifying examination (OBC Category)
- Minimum of 40% marks in the qualifying examination (SC, ST & Cat-I)

#### Curriculum

- Curriculum is as prescribed by Karnataka State Law University for both the courses.
- The duration of the B. A. LL. B and B.B.A. LL. B course shall be five years consisting of ten semesters.
- Each Academic year shall be divided into two semesters.
- Each semester shall consist of 6 months of 18 weeks
- The medium of Instruction is English

- The Pattern of End Semester Examination conducted by the University (KSLU) is 80-20.
  - 1. 80 Marks for External Examination.
  - 2. 20 Marks for Internal Examination

#### **Promotion**

It is mandatory that every student is required to pass a minimum of one subject/paper in each semester or two papers in that year (1st & 2nd semesters collectively) so that he/she can continue to 3rd semester failing which the candidate will become ineligible to take admission for 3rd semester and so on. He /She will then have to compulsorily repeat the course along with the junior batch students. (i.e., year back students)

Students are required to successfully complete the entire course within seven years from admission to the course.

#### **Attendance**

It is compulsory for the admitted students to strictly attend all the classes without fail. A student who has put in less than 85% of attendance shall not be permitted to appear for end-of- semester examination in a given course.

### **Disciplinary Rules**



Each student admitted to the degree course should strictly adhere to the institute's disciplinary rules. Students are required to wear uniform on every Monday, Thursday and whenever instructed. There shall

be no admission into the campus without student ID cards issued by the institute. Ragging is a punishable offence and is prohibited. Student behaviour will be monitored. Any, disregard to the institute disciplinary rules will be subjected to strict action.
