Formatting and Citation Guidelines

1. The manuscript must be submitted in Microsoft Word format (.doc or .docx).
2. Main text: Times New Roman, 12-point font, 1.5 line spacing.
3. Footnotes: Times New Roman, 10-point font, single line spacing.
4. Citation style: OSCOLA
